

## **Currajong 1 Exploration Well – Operations Update**

Buru Energy Limited (Buru Energy) provides the following update on operations at the Currajong 1 exploration well.

Since the last report the issues with the 13<sup>3</sup>/<sub>8</sub> inch (340mm) casing string have been mitigated and the Joint Venture has made the decision to install the contingent 9<sup>5</sup>/<sub>8</sub> inch (244 mm) casing string before drilling ahead.

Wireline logs have also now been acquired down to the current depth of 1,954 metres and the current operation is rigging up to run the 9% inch casing.

Once the 9<sup>5</sup>/<sub>8</sub> inch casing operations have been completed, the well will be drilled ahead in 8<sup>1</sup>/<sub>2</sub> inch (216mm) hole through the main objective section.
