## **ASX ANNOUNCEMENT (ASX: BRU)      9 February 2012**

### **WEEKLY DRILLING PROGRESS REPORT VALHALLA NORTH-1**

---

Buru Energy Limited (“**Buru**” or “**Company**”) provides the following weekly update on drilling operations at the Valhalla North-1 well as at 06:00hrs, 9 February 2012 (AWST).

The Valhalla North-1 well is the fifth well in the Buru – Mitsubishi Corporation (“**MC**”) Joint Exploration Program in the Canning Superbasin that commenced in June 2011. Buru and MC each have a 50% interest in the Valhalla North-1 well and in EP 371, with MC contributing 80% of the cost of the well under the terms of its farm-in agreement with Buru. The Valhalla North-1 well is being drilled by Ensign Rig #32 to a planned total depth of 3,400 metres. It is expected to take 38 days to drill on a cased and completed basis.<sup>1</sup>

Since the last progress report for Valhalla North-1, 9½” intermediate casing has been run and cemented to a measured depth of 2,035m. As at 06:00hrs today, the well was being prepared to commence drilling ahead in 8½” hole to the first objective, the Upper Laurel Formation.

In accordance with its policy of releasing weekly drilling progress reports, the Company expects to issue a further drilling progress report on 16 February 2012, subject to any material events occurring in the meantime.




