Share Purchase Plan Closes Heavily Oversubscribed

Buru Energy is pleased to advise the results of the Company's Share Purchase Plan ("SPP") which closed at 5pm Sydney time on Friday 6 September. The SPP was heavily oversubscribed, with subscription applications of some \$22.2 million being received from 2,092 shareholders.

Under the terms of the SPP, the total amount of funds to be raised was capped at \$5 million. Consequently, applications from shareholders will be scaled back in accordance with the terms of the SPP, under which each application will be treated equally and scaled back on a pro-rata basis. This means that each application will be scaled back at the ratio of approximately 0.224 for each share applied for and rounded down to the nearest whole number of shares.

Under the terms of the SPP the allocation price for the shares is the placement price of \$1.65 which will result in the issue of 3,029,278 new shares for total consideration of \$4,998,309.

The new shares will be allotted on 13 September with trading of the new shares to commence on 16 September. Refund of application monies via direct credit will be completed by 16 September. Allotment and refund advices, together with refund cheques for those applicants who do not have bank account details recorded on their registered holding, will be despatched to applicants by 16 September.

The SPP is the last component of the comprehensive funding package announced on 8 August 2013. The Board has been extremely pleased by the support from shareholders for both the institutional placement and the SPP which were both substantially oversubscribed.
