WEEKLY DRILLING PROGRESS REPORT LEANDER-1st1

Buru Energy Limited ("**Buru**" or "**Company**") provides the following update on drilling operations at the Leander-1st1 well as at 06:00hrs, 26 August 2010 (AWST). Buru holds a 100% interest in this well.¹

Note that the well has now been designated Leander-1st1 to reflect the drilling of the sidetrack

During the week the sidetrack operation was commenced with the setting of a cement plug above the fish. The first sidetrack attempt was unsuccessful due in part to contractor equipment malfunction. A second attempt at the sidetrack was then undertaken and this was successful, and the well has now been drilled ahead to 1523.5 metres using the sidetrack drilling assembly. The forward program is to change the bottom hole assembly and recommence drilling ahead to the several Anderson Sandstone objectives which are expected to be encountered during the course of drilling over the next week.

In accordance with its policy of releasing weekly drilling progress reports, the Company expects to issue a further drilling progress report on 2 September 2010, subject to any material events occurring in the meantime.

The forward program is to change the bottom hole assembly and recommence drilling ahead to the various Anderson Sand target formations.
