## ASX ANNOUNCEMENT (ASX: BRU) 2 September 2010

#### WEEKLY DRILLING PROGRESS REPORT LEANDER-1st1

Buru Energy Limited ("**Buru**" or "**Company**") provides the following update on drilling operations at the Leander-1st1 well as at 06:00hrs, 2 September 2010 (AWST). Buru holds a 100% interest in this well.<sup>1</sup>

During the week the well has been drilled ahead from 1,523.5 metres to 2,117 metres. Fair to good hydrocarbon shows were encountered in the carbonates of the Laurel section but there does not appear to be significant reservoir development associated with these shows. The well is currently drilling in the Yellowdrum Formation with minor hydrocarbon shows and will be drilled ahead to the secondary objective of the Nullara Formation carbonates which are the productive horizon at the Blina Field.

In accordance with its policy of releasing weekly drilling progress reports, the Company expects to issue a further drilling progress report on 9 September 2010, subject to any material events occurring in the meantime.
