FINAL DRILLING PROGRESS REPORT LEANDER-1st1

Buru Energy Limited ("**Buru**" or "**Company**") provides the following update on drilling operations at the Leander-1st1 well as at 09:00hrs, 7 September 2010 (AWST). Buru holds a 100% interest in this well.¹

The well has now been drilled ahead to a total depth of 2,280 metres and wireline logs have been run. No hydrocarbon zones warranting further testing were noted on the logs, and the well will now be suspended and the rig released.

The rig will then have a short period of preventative maintenance before running the frac packer and tubing string into the Yulleroo-2 well, and then spudding the Paradise-1 well.

The Leander-1st1 well is being suspended for possible re-entry and sidetrack to test an interpreted hydrothermal dolomite anomaly some 500m to the west of the current well location. This operation would require the larger rig that Buru currently intends to mobilise into the Canning Superbasin for the 2011 drilling program.

Buru's Executive Director Eric Streitberg commented:

"Whilst we are disappointed with the results of this well, it is one of a series we will be drilling this year and does not have any impact on the prospectivity of the next wells in the program. We are looking forward in the near term to both the frac and test of Yulleroo-2, and the spud of Paradise-1."
