WEEKLY DRILLING PROGRESS REPORT VALHALLA NORTH-1

Buru Energy Limited ("**Buru**" or "**Company**") provides the following weekly update on drilling operations at the Valhalla North-1 well as at 06:00hrs, 23 February 2012 (AWST).

The Valhalla North-1 well is the fifth well in the Buru – Mitsubishi Corporation ("**MC**") Joint Exploration Program in the Canning Superbasin that commenced in June 2011. Buru and MC each have a 50% interest in the Valhalla North-1 well and in EP 371, with MC contributing 80% of the cost of the well under the terms of its farm-in agreement with Buru. The Valhalla North-1 well is being drilled by Ensign Rig #32.

Since the last progress report, Valhalla North-1 has been drilled ahead in 8½" hole to a measured depth of 3,356 metres, and the current operation is pulling out of the hole to inspect the bit due to slow drill rate.

The top of the Lower Laurel Clastics section is interpreted to have been encountered at approximately 2,830 metres measured depth, where a significant increase in background gas occurred. Continued high levels of background gas have been observed over the whole of the Lower Laurel Clastics section with gas peaks up to 1,300 units in sand prone sections.

The section drilled to date has established that the gas shows in the Valhalla North-1 well are consistent with those observed in Valhalla-2, and extend over a similar interval of some 1,300 metres to the current depth and were continuing at that point. Consequently it has been agreed that the current depth will be the total depth of the well, and a full suite of wireline logs will now be run to evaluate the $8\frac{1}{2}$ " hole section.

In accordance with its policy of releasing weekly drilling progress reports, the Company expects to issue a further drilling progress report on 1 March 2012, subject to any material events occurring in the meantime.




